Eligible 8th grade students are invited to participate in a special, end of the year celebration aboard the *Spirit of Navy Pier*, by City Cruises in beautiful downtown Chicago.

The trip is scheduled for **Thursday, May 23, 2024**. Students will come to school at their regular time, and then be transported by bus to Navy Pier for a day on the water! They will return before the day's end so that bus riders will be able to get home, without making special arrangements for pick-up.

The cost of the trip is \$65.00. That cost includes transportation to and from Navy Pier and food, beverages and entertainment while on the boat. **Your child's completed permission slip (see attached) and payment are due back to us by no later than Friday, April 19th.** Please make checks/money orders payable to CMMS for the exact amount. **Reservations will be taken on a first come first served basis.** Permission slips and money should be handed in to Mrs. Bond in the Main Office.

Students are expected to wear school appropriate clothing for this event. Our 8th grade teachers, staff and administrators will be chaperoning the students.
